Remember your Association is there to represent our common interests affecting our Lake and properties, but we are not there to police Lake activities, interpret or enforce by-laws and municipal regulations.

Before you pick up that phone or dash off that email, remember that above all we are a community just like any other neighborhood. Respecting others rights to enjoy their property and using consideration for all neighbours make the Lake a safer and more enjoyable place for us all. Summer is brief, we are there for a good time, not a long time. Better to approach a neighbour with your concerns to avoid bad feelings and spoiled weekends. In some cases those neighbors may be seasonal renters and do not understand the common sense behaviour Lake living requires. If in the end diplomacy fails use the numbers below to assist.
